

## Uchucklesaht Tribe Government Elections 2023

## **Certification by Chief Electoral Officer**

- I, <u>Kit Spence</u> of <u>North Saanich</u>, in the Province of British Columbia, Chief Electoral Officer for the Uchucklesaht Tribe, DO SOLEMNLY DECLARE THAT:
- 1. Duly appointed electoral officers were present at <u>Port Alberni</u> on <u>November 11, 2023</u> when Citizens of the Uchucklesaht Tribe voted in an election in accordance with the Uchucklesaht Tribe Government Elections Act UTS 35/2014.
- 2. A true copy of the Notice of Election is attached as Exhibit "1" to this Declaration.
- 3. In accordance with section 2.4 of the Uchucklesaht Tribe Government Elections Act UTS35/2014 the Notice of Election was posted at least sixty (60) days prior to the Election Day.
- 4. The voting procedure was conducted in accordance with Uchucklesaht Tribe Government Elections Act UTS 35/2014
- 5. The results of the election for Cootes 1 Family Councillor is as follows:
- a) the names of <u>102</u> Voters for the Cootes\_1 Family appeared on the Voters List prepared pursuant to Part 5 of Uchucklesaht Tribe Government Elections Act UTS 35/2014 and the number of Voters who were entitled to cast a vote was <u>102</u>;
- b) <u>25</u> Cootes 1 Family Councillor ballots were cast in the election;
- c) <u>0 (zero)</u> Cootes\_1 Family Councillor ballots were rejected in accordance with section 10.4 (b) (i)(A) of the Uchucklesaht Tribe Government Elections Act UTS 35/2014);
- d) <u>0 (zero)</u> Cootes\_1 Family Councillor ballots were spoiled in accordance with section 7 of the Uchucklesaht Tribe Government Elections Act UTS 35/2014 and were not counted in b. above.

The following table lists in detail the results of the count of the valid ballots cast:
